PRESENTATION-CBS Outdoor Billboard (Mr. William Holle)

A presentation to the Committee was made regarding the current Bill board which is Block 28 Lot 6 on the Eagleswood Township Tax Map. Mr. Hollie was proposing tearing down the current billboard and replacing it with four. Mr. Hollie showed the Committee a picture that he had prepared showing his proposal. The committee was not in favor of his proposal – not liking the display. After some discussion it was asked to have the Clerk speak to the Zoning Official to clarify some information with regards to heights and setbacks. The committee asked Mr. Hollie to redo his current idea and make changes and forward to the Clerk for her to distribute to the committee.

Tom Morris- Cox Crossing Road- Mr. Morris has concerns regarding the Eaglesnest Air Port. Mr. Morris has issues with the flight pattern of the Skydiving school.

Michele Paccione-Laurel Hill Lane- Mrs. Paccione has issues with the Eaglesnest Air Port. She is concerned that her house is in the Crash Zone, she states that the Skydiving School is buzzing over her house all day long and she is concerned that this has put her in a dangerous situation. She stated that there are many residents with the same concern and feeling with regards to the Airport. She stated she is willing to contact the FAA and find out what can be done with regards to the Airport Skydiving.

The first order of business under discussion was the request for a Crosswalk on Rt 9 across from the West Creek Post Office. The Committee decided to have a Resolution prepared in support of this and will have placed on the next Township Committee meeting in September.

The second order of discussion was a call was received from a resident requesting additional street lighting placed on South Creek Drive-Dock Road-after discussion the Committee determined to take no action at this time.

The third order of discussion was Council of Affordable Housing-after discussion the Committee decided to revisit COAH in 2014.

The fourth order of discussion was the Lease agreement with Fonte LLC (Antoinettias) Block 8 Lot 4 at the end of Cedar Run Dock Road- It has been determined by the Acting Chief Financial Officer that we have not been receiving the annual rent of \$2,500.00 since 2011-2012 or 2013. Robin will check with Mr. Monahan and have a letter drafted and sent to Fonte LLC regarding the delinquent rent.
