# TOWNSHIP OF EAGLESWOOD REGULAR MEETING MARCH 23, 2011

## **CALL TO ORDER**

The Regular Meeting of the Township Committee of the Township of Eagleswood was called to order by Mayor Wayne Thomas at 7:00 p.m. Mayor Thomas led in the Salute to the Flag.

#### **ROLL CALL**

Those members present upon roll call were Debra Rivas and Wayne Thomas. James Pine was absent. Also present were Thomas Monahan, and a few residents.

## **PUBLIC COMMENT ~ Five Minute Limit (Please state name and address)**

**MOTION** – Debra Rivas made a motion to open the meeting to public comment, seconded by Wayne Thomas, and unanimously carried.

Mae Wagner, Dock Road asked who would maintain the brick pavers downtown. Wayne Thomas explained that it is the homeowner's responsibility. Ms. Wagner asked what public works does on a weekly schedule. Mayor Thomas explained that they pick up recycling, do routine maintenance, work on the odor control building, handle sewer emergencies, pick up brush, cardboard. If it is raining, they have inside work to do. Ms. Wagner asked if they would trim the branches, etc. downtown where no structure is, to which Mayor Thomas said there are trash/recycling bins going in; and, Public Works will trim the branches. Debra Rivas added that they do have a property maintenance law. Mayor Thomas said that when the community clean up occurs, they could target that area and asked if Ms. Wagner would help. She will.

Ms. Wagner said that Little Egg Harbor School priced out their health benefits and got a cheaper price. She asked if the Township could also do this. The Clerk responded that she does this every year.

Mae Wagner asked if Public Works monitors the miles, gas for their vehicles. Mayor Thomas advised her that Public Works does and also does the maintenance work. The older vehicles are starting to cost more. Ms. Wagner wanted to know how many miles a year they travel, to which the Mayor responded he didn't know. Debra Rivas said they split two days of Talbert's schedule to have him work Saturday and Sunday and have off Monday and Tuesday. This cuts down on the overtime. Debra Rivas also advised Ms. Wagner there was always two clean up days; however, volunteers are hard to get twice a year.

Bill Gordon, Sprague Avenue, asked if there was any resolve with Alice Miller and her pay and benefits. Mayor Thomas explained that they had meetings to discuss this and reduced the cost of the benefits paid by the town by 34%. Debra Rivas explained that she met with Ms. Miller to discuss this. Wayne Thomas explained that the contract with Little Egg Harbor is up the end of the year and they will discuss the program. Debra Rivas explained that the school is going to extend the summer program day with the parents paying for the difference in what the MAC grant covers and the extra hours.

Mr. Gordon asked who from here was in the PAL program. Debra Rivas explained that this is in Little Egg Harbor and they do not donate to them anymore.

Mae Wagner asked if Tuckerton was part of MAC, to which Debra Rivas explained that they are separate.
