NO COLLECTION IF TRASH & RECYCLING IS COMMINGLED - TOO HEAVY - INCORRECT CONTAINER

EAGLESWOOD TOWNSHIP DOES NOT HAVE A PUBLIC YARD

Collection of refrigerators, freezers, dishwashers, washers, dryers and propane tanks are subject to N.J. \$12 Collection Fee for each item – pay at the Municipal Bldg Monday-Friday 9am-4pm (cash, check or money order payable to “Eagleswood Township”)

TUESDAY:

1.) Regular “Trash” Collection:

Place township approved containers at curb after 6:00 pm Monday or before 5:00 am Tuesday with lids, handles, appropriate drainage & not weigh more than 40 lbs when filled – will not be collected if weighing more -- a maximum of six (6) containers are permitted for collection p/wk

2.) “Bulk” Non-Recyclable Trash Collection:

*Only one (1) to two (2) items per weekly collection permitted and may include items like >> grills, metal, mattresses, furniture, wooden cabinets/tables/chairs must be broken down and put in a township approved container, carpeting/padding must be cut into 4 ft. lengths, rolled up & tied, -- items must not weigh more than 40 lbs ****Per Ordinance No.2010-01 – Eagleswood Township is NOT responsible for construction debris collection - dumpster required*****

WEDNESDAY:

“Recycling” Collection – (all bottles, cans, newspapers, flattened cardboard, junk mail, magazines, & mixed paper) -- **DO NOT PUT IN PLASTIC BAGS/WILL NOT BE COLLECTED**

All can be placed in one township approved recycling container at curb after 6:00 pm Tuesday and before 5:00 am Wednesday with lids, handles, appropriate drainage & not weighing over 40 lbs. when filled – will not be collected if weighing more -- A maximum of six (6) containers are permitted for collection p/wk

ADDITIONAL INFORMATION:

BRUSH & LEAVES COLLECTION – 2ND & 4TH Thursday – **NO PLASTIC BAGS/WILL NOT BE COLLECTED - If using bags must be PAPER BAGS ONLY**

A maximum of six (6) township approved containers/paper bags are permitted per collection. Any branches must be in prepared bundles -- not to exceed 4 ft in length, 2 ft in diameter and not to exceed 40 lbs (also branches cannot exceed 4 inches in diameter)

Electronics (computers, printers, TV's, DVD players, VCR's, stereo components, printers, microwave ovens etc...), fluorescent light bulbs, rechargeable batteries, motor oil (no gas or water mixture), paint, hazardous waste

NOT RECYCLING = ****put in trash container or trash bag**** pizza boxes, food-contaminated items, plates, glasses, pots, pans, alkaline batteries, bulbs, window glass, auto glass, pvc, buckets, pails, toys, Pyrex, mirrors, styrofoam, shredded paper, hoses, flower/shrub pots, mulch (– etc...)
